NOTES: Passengers are authorized two pieces of baggage up to 70 lbs each. Mobility assist equipment (to include powered wheelchairs) weighing over 100 lbs, and footwear such as five-toe-shoes, sandals, flip-flops, crocs, high heels, etc. are prohibited on AMC flights. Infants under 6 weeks old, and women beyond 34th week of gestation or less than 6 weeks post-partum must be certified in writing by a responsible physician as healthy to fly. Some locations have limited support capability, travelers must ensure availability of transportation and lodging at their next location.
