Passengers traveling Space-A can mark themselves present within 24hrs of roll call BUT, should be marked present NLT 30 minutes prior to roll call time. Prior to check-in counters opening, passengers may mark themselves present in the AMC Office located by Baggage Claim #5. The time you mark present does not have weight upon the selection process, choose what is most convenient to you. Selection is based upon your CATEGORY and then your DATE & TIME of sign up. Please come ready with I.D's, passports and all travel documents such as leave forms, EML form and travel letters for ALL travelers.

All travelers MUST be present at the time of roll call selection at the AMC Ticketing Counter.
