2.3.1.3. All personnel conducting business at the Al Udeid Passenger Terminal or PERSCO Customer Service must wear a military uniform; or a collared shirt or equivalent (shoulders covered), with slacks or blue jeans without holes, and covered-toe shoes.

ATTENTION:

9 AF (AFCENT) CC Passenger Routing Instruction Appendix D; Section 7

- All U.S. Military Personnel traveling Intra-Theater on U.S. AirForce Aircraft between U.S. Military bases are required to travel in uniform.
- Military passengers traveling to or from Non-U.S. Military Bases are not required to travel in uniform.
- All other passengers will wear civilian clothing that is not inappropriate or pose a safety risk.
- Passenger travel requirements in the Foreign Clearance Guide will have precedence.

ATTENTION:

379 AEWI 1-1; Section 1.2

- Military personnel arriving or departing AUAB via contracted rotators or military aircraft will wear the desert flight duty uniform (DFDU) or utility uniform (i.e., Operational Camouflage Pattern (OCP) or approved sister-service uniforms IAW USAFCENT 36-2903)
- AFOSI personnel will dress as authorized by the AFOSI/CC

Check-In Procedures

Fragged Passengers traveling within the AOR:

Check in starts **6 HOURS** prior to departure and
YOU MUST be checked in no later than **3 HOURS** prior to
departure.

Booked Passengers Redeploying (Rotator):


Check in starts **24 HOURS** prior to departure.

Traveler's Checklist

- ✓ Uniform is required to fly and required for check-in
- ✓ ID Card
- ✓ 1 Copy of orders that PSA can keep
- ✓ Space-A PAX:
 - ✓ ID and 1 copy of orders/leave form
 - ✓ Federal inspection fees may apply (Eagle Cash)

- ✓ Bring all baggage and carry-on
 - ✓ 2 Checked bags (70 lbs. / 62 Linear inches ea.)
 - ✓ Check orders to see what you are authorized
 - ✓ “Excess Baggage Authorized” = PAX authorized the amount of bags listed on orders
 - ✓ not authorized excess baggage.




72 Hour Flight Schedule
