### **For Passengers Traveling on PCS Orders**

1. To be **TRAVEL READY**, all passengers are required to present the following:
  - 2 copies of Orders
  - CAC for Member/Sponsor
  - Dependent ID (needed to verify dependent status)
    - DD Form 1172 can be obtained from your nearest MPF or in MilConnect for all dependents without ID cards.
  - Passport and/or certified copy of birth certificate (needed to verify citizenship) for everyone identified on travel orders.
  - All checked bags, carry-on bags, car seats, strollers, pets inside pet kennels and all veterinary documentation.
  - Firearms/ammo:
    - Passengers traveling with firearms CANNOT utilize Early Bird Check-in
    - Valid Guam Firearms ID (FID), Guam registration of all individual firearms and a TSA approved container
  - Passengers who are not travel ready may experience delays or loss of booking.
  - **As of 09 August 2025, The Patriot Express will be completely cashless. Passengers are encouraged to have credit/debit cards. We will NOT be able to accept checks!**
2. **PCS CHECK-IN: 30 MAY 2026/ 0800-1700L**
  - Passengers must be “travel ready.” See *ALL items in #1*
    - Passengers who are not travel ready may experience delays or loss of booking!

### **For Space-Available Travel on the Patriot Express**

1. To be **TRAVEL READY**, all passengers are required to present the following *applicable* items:
  - Approved Leave Forms
  - CAC or DoD Affiliated identification card
    - Dependent ID with appropriate sponsor affiliation (needed to verify dependent status)
    - A DD Form 1172 can be obtained from your nearest MPF or in MilConnect for all children without ID cards.
  - Accompanied or unaccompanied command sponsorship letter
  - Passport and/or certified copy of birth certificate (needed to verify citizenship)
  - All Checked bags, carry-on bags, car seats, strollers.
  - **As of 09 August 2025, The Patriot Express will be completely cashless. Passengers are encouraged to have credit/debit cards. We will NOT be able to accept checks!**
2. **Space-A Roll Call** will begin on **30 MAY 2026/ 1700L**
  - All space-available passengers MUST mark themselves PRESENT 1 HOUR prior to roll call.
  - Passengers utilizing space-available travel on the Patriot Express must be “travel ready.”
  - Failure to be travel ready will DELAY the processing of your travel!

**For Passengers Traveling on PCS Orders**

- To be **TRAVEL READY**, all passengers are required to present the following:
  - 2 copies of Orders
  - CAC for Member/Sponsor
  - Dependent ID (Needed to verify dependent status)
  - Passport and/or certified copy of birth certificate (needed to verify immigration status) for everyone identified on travel orders.
  - All checked bags, carry-on bags, car seats, strollers, pets inside pet kennels and all veterinary documentation
  - Firearms/ammo –
    - Passengers traveling with firearms CANNOT utilize Early Bird Check-in
    - Valid Guam Firearms ID (FID), Guam registration of all individual firearms and a TSA approved container.
  - Passengers who are not travel ready may experience delays or loss of booking.
  - As of 09 August 2025, The Patriot Express will be completely cashless. Passengers are encouraged to have credit/debit cards. We will **NOT** be able to accept checks!
- Early Bird PCS Check-In:** Checking-In the Day Prior to your DEPARTURE, *beat the rush!*
  - Early Bird Check-in is **30 MAY 2026 FROM 1830L – 2300L**
  - The Passenger Terminal **will not hold any firearms overnight.**
  - Passengers utilizing Early Bird Check-in must be “travel ready.” See *ALL items in #1*
  - Passengers utilizing Early Bird Check-in must arrive back to the terminal no later than **31 MAY 2026 / 1930L**
  - Failure to be travel ready will DELAY the processing of your travel.
- Normal PCS Check-In:** **31 MAY 2026 / 1200L to 1930L**
  - Passengers WHO DO NOT check-in by **31 MAY 2026 / 1930L** will have their reservation cancelled.
  - Passengers utilizing NORMAL Check-in must be “travel ready.” See *ALL items in #1 above*
  - Utilizing Early Bird check-in will decrease delays and processing day of!

**For Space-Available Travel on the Patriot Express**

- To be **TRAVEL READY**, all passengers are required to present the following *applicable* items:
  - Approved Leave Forms
  - CAC or DoD Affiliated identification card
    - Dependent ID with appropriate sponsor affiliation (needed to verify dependent status)
    - A DD Form 1172 (with your dependents DOD ID#) can be obtained from your nearest MPF or in MilConnect for all dependents without ID cards
  - Accompanied or unaccompanied command sponsorship letter
  - Passport and/or certified copy of birth certificate (needed to verify citizenship)
  - All checked bags, carry-on bags, car seats, strollers
  - As of 09 August 2025, The Patriot Express will be completely cashless. Passengers are encouraged to have credit/debit cards. We will **NOT** be able to accept checks!
- Space-A Roll Call** will begin on **31 MAY 2026 / 1930L**
  - All space-available passengers MUST mark themselves PRESENT 1 HOUR prior to roll call.
  - Passengers utilizing space-available travel on the Patriot Express must be “travel ready.”
  - Failure to be travel ready will DELAY the processing of your travel!

### For passengers arriving in Andersen AFB

1. All passengers whose destination is **Andersen AFB Guam** will need to be cleared by Guam Customs before being allowed to claim their baggage and leave the terminal.
2. The parking lot located in front of the terminal is designated for passengers traveling with AMC. Family members, friends, or sponsors picking up passengers from Patriot Express are required to park in the short-term parking lot adjacent to the Connex containers. **DO NOT BLOCK THE BUS LANE!**
3. Inbound passengers and baggage are estimated to arrive at the passenger terminal **30 MAY 2026/ 1600-1700L**  
**Actual flight arrival time may vary. Please take this into consideration when arranging your visit to the terminal to meet inbound passengers.**

### Guam Electronic Declaration Form

The Guam Electronic Declaration Form (Guam EDF) is a **MANDATORY** digital form that all arriving passengers will need to complete before entering the island of Guam.

- The Guam EDF can be filled out 72 hours prior to the date of arrival.

**For passengers arriving in Andersen AFB**

2. The parking lot located in front of the terminal is designated for passengers traveling with AMC. Family members, friends, or sponsors picking up passengers from Patriot Express are required to park in the short-term parking lot adjacent to the Connex containers. **DO NOT BLOCK THE BUS LANE!**
3. Inbound passengers and baggage are estimated to arrive at the passenger terminal **31 MAY 2026 / 1800-1900L**. **Actual flight arrival time may vary. Please take this into consideration when arranging your visit to the terminal to meet inbound passengers.**
