### NOTICE FOR ALL AMC PASSENGERS PCSing With *DOGS*

Effective 01 August 2024, all dogs to include service dogs entering or returning to the United States from an overseas location must adhere to new, specific requirements based on the location of the animal 6 months prior to entering the United States and where the canine received their Rabies vaccinations, if required.

### NOTICE FOR ALL ACTIVE-DUTY MILITARY TAKING LEAVE TO JAPAN

#### IDENTIFICATION CREDENTIALS FOR LEAVE TRAVEL:

- Military personnel on leave require a Regular (blue tourist) Passport. However, US military personnel on leave returning to their unit of assignment in Japan may travel on military ID card and travel orders.
  - Visa not required for stays up to 90 days.
- Civilian personnel on leave require a Regular (blue tourist) Passport

**\*ATTENTION\*** The Passenger Terminal will open for all AMC Missions NLT 1 HOUR Prior to aircraft arrival or NLT 5 HOURS prior to aircraft departure, whichever comes first during hours outside of normal duty operations.

### **Flight Check-In Requirements**

**Space-R passengers can check-in the day prior for Patriot Express (PE) flights.  
Early Bird check-in hours are from 1000L-1800L.**

**When utilizing the option for Early Bird check-in, passengers are required to have all checked baggage, carry-on items, and pets within their possession. Documentation such as, but not limited to; passports, orders, and animal clearances must be on hand and readily available during processing.**

**Required Documents for Check-In may include:**

- Status of Forces Agreement (SOFA) Stamped Passports**
- DOD ID for all travelers who are 14 years old or older. For travelers under the age of 14 years old, Defense Enrollment Eligibility Reporting System (DEERS) documents will be required for proof of sponsorship**
- Copy of orders and all documents**
- Pets inside their crates or kennels with all required documentation (rabies vaccines, health declarations, valid within 10 days prior to departure)**
- All checked baggage including carry-ons**

### **NOTICE FOR ALL AMC PASSENGERS**

Space-R passengers are required to check-in No Later Than **3 HOURS 30 MINUTES** prior to Patriot Express (PE) Flight Departure. Space-A Roll Call will start **3 HOURS 30 MINUTES** prior to Patriot Express (PE) Flight Departure.

Space-A Roll Call for all other flights will be **2 HOURS 20 MINUTES** prior to departure. Arrive at least 30 minutes prior to ensure you are on the Space-A present list before Roll Call begins.

STARTING 01 JAN 2026, NATIONALS OF COUNTRIES/REGIONS ELIGIBLE FOR VISA-FREE ENTRY ARE REQUIRED TO GET  
KOREA ELECTRONIC TRAVEL AUTHORIZATION (K-ETA) APPROVAL TO BOARD A FLIGHT BOUND FOR REPUBLIC OF KOREA.  
THOSE WHO ALREADY HAVE A K-ETA CAN USE IT UNTIL IT EXPIRES. PASSENGERS WITH A K-ETA ARE EXEMPT FROM
