United States	As of USTRANSCOM Guidance released 14 Jun 2022, Covid-19 Tests for the United States are no longer required for entry.
Niger (Agades/Niamey)	Fully vaccinated or PCR or Recovery Letter within 90 days of positive test result
Djibouti	Fully vaccinated or PCR or Recovery Letter within 90 days of positive test result.

COVID-19 Test Requirements within 72hrs. of Arrival (Vaccinated Personnel)

Kuwait	No Further Entry Requirements as of 27 July 2022.
Turkey	Fully Vaccinated OR Proof of Recovery Letter starting from 28 days after FIRST positive PCR result OR Negative PCR Test Within 72hrs.
Qatar	PCR(48 hours) OR Proof of Recovery Letter within 90 Days, including a positive PCR test result (print out) OR Antigen within 24 hours

**INBOUND PASSENGERS FROM BALTIMORE INTERNATIONAL AIRPORT, MARYLAND
EFFECTIVE IMMEDIATELY**

-The German Zoll resumed normal operations for veterinarian services in the Ramstein Passenger Terminal after a 2-year hiatus for Covid-19 Protocols. Effective immediately: The German Zoll will charge each inbound pet owner a one-time fee of €55 (1 or 2 pets), to read their Avid microchip(s), and review veterinary documentation. The German Zoll will have credit card readers available on site to process funds in the inbound customs area upon arrival. Please be advised that this is a Host Nation requirement.

-In keeping with major airline in-cabin kennel requirements: Soft-sided kennels should be constructed of leak-proof/water repellent padded nylon with mesh ventilation on at least two sides.

-Kennel size must not exceed 18”L x 11”W x 10.5” H



Privacy Act Information



Authority: 10 USC 8013, Secretary of the Air Force and E.O. 9397 (SSN).

Purpose: Passenger Name Records are used to prepare aircraft manifests for passenger identification processing and movement on military aircraft, commercial contract (charter) aircraft, and on seats reserved (blocked) on regularly scheduled commercial aircraft at military and civilian airports.

Records in this system are also used to develop billing data to the using Military Service or other organization, determine passenger movement trends, forecast future travel requirements, and identify, research, and resolve transportation related problems.

Check-In Information

- Early Check-in for Patriot Express Flights Begin **24 Hours PRIOR** to Estimated Departure Time(ETD). It is **HIGHLY** recommended that all Passengers Check-in Early.
- PCS/TDY personnel **MUST** have a copy of their orders with either their DoD ID Number or FULL SSN for the Passenger Terminal to keep. ID Cards for Dependents of age 10+ and all passports **MUST** be present at the time of Check-in. You must have all your bags and pets at the time of check in including carry-on items.
- PCS/TDY personnel **MUST** be checked in by their **No Later Time(NLT)** or risk being removed from the flight.

- **TRANSPORTATION OF FIREARMS AND INSPECTION OF CHECKED BAGGAGE**

PASSENGERS REFUSING TO PRESENT IDENTIFICATION AND/OR PERMIT CHECKED BAGGAGE INSPECTION MAY NOT BE TRANSPORTED.

- **CARRIAGE OF HAZARDOUS MATERIALS**

FEDERAL LAW FORBIDS THE CARRIAGE OF HAZARDOUS MATERIALS ABOARD AIRCRAFT IN CHECKED OR HAND CARRIED BAGGAGE. A VIOLATION CAN RESULT IN PENALTIES OF UP TO \$25,000 AND FIVE YEARS IMPRISONMENT

HAZARDOUS MATERIALS INCLUDE EXPLOSIVES, COMPRESSED GASES, FLAMMABLE LIQUIDS AND SOLIDS, OXIDIZERS, POISONS, CORROSIVES AND RADIOACTIVE MATERIALS.

THERE ARE SPECIAL EXPECTATIONS FOR SMALL QUANTITIES OF LIQUIDS, GELS, OR AEROSOLS, THREE OUNCES PER CONTAINER, PACKED IN A ONE QUART ZIP CLOSURE BAG. E-CIGARETTE SMOKING MATERIALS ARE ALSO PERMITTED IN HAND CARRIED BAGGAGE..

- **TRANSPORTATION OF NARCOTICS**

FEDERAL LAW PROHIBITS THE TRANSFER, USE OR POSSESSION OF NARCOTICS INCLUDING MARIJUANA, ABOARD AIRCRAFT.

- **CHECKED BAGGAGE LIMITATIONS**

PASSENGERS ARE ENTITLED TO TWO PIECES OF CHECKED BAGGAGE NOT TO EXCEED 70LBS. EACH FOR A TOTAL OF 140LBS. NEITHER WILL EXCEED 62 LINEAR INCHES (LENGTH+WIDTH+HEIGHT).

- **IDENTIFICATION OF CHECKED BAGGAGE**

GOVERNMENT REGULATIONS REQUIRE THAT NO PASSENGER'S BAGGAGE BE CHECKED FOR TRANSPORTATION UNLESS THE PASSENGER'S NAME IS ON THE OUTSIDE OF SUCH BAGGAGE.

- **CARRY-ON BAGGAGE LIMITATIONS**

FAA REGULATIONS REQUIRE THAT CARRY-ON BAGGAGE BE LIMITED TO ITEMS THAT CAN BE CONVENIENTLY STOWED UNDER YOUR SEAT OR IN AN APPROVED STORAGE COMPARTMENT. ITEMS WHICH CANNOT MEET THIS REQUIREMENT MUST BE CHECKED AS REGULAR BAGGAGE.

Emergency Restrictions / Prohibition Order Of the United States Department of Transportation



Samsung have issued a recall of all of its Galaxy Note 7 devices. This includes all original and replacement Galaxy Note 7 devices.

- These devices contain batteries which may not meet the United Nations testing requirements for transportation on board an aircraft.
- **They are prohibited anywhere on board all aircraft by U.S. Federal regulation.**
- **You may not pack a Samsung Galaxy Note 7 in your checked baggage. You may not carry one on board the aircraft in your carry-on baggage or on your person.**

Emergency Restrictions / Prohibition Order Of the United States Department of Transportation



As a reminder, Federal Aviation Administration regulations prohibit passengers from drinking alcohol on board aircraft unless the air carrier serves it.

Passengers who disregard this regulation can be turned over to Security Forces or Local Law Enforcement.

The FAA restriction is referenced in 14 CFR, Chapter I, Subchapter G, Part, 121, Subpart T, paragraph 121.575.

MANDATORY FACE COVERING POLICY

IAW USTRANSCOM/AMC guidance dated 09 Dec 2020 the following is required for all passengers.

- All passengers in USTRANSCOM/AMC passenger terminals and while utilizing military or commercially contracted aircraft **MUST** wear face coverings when personnel cannot social distance (Minimum of 6 feet). The use a masks with exhalation valves or vents is **PROHIBITED**. (IAW CDC GUIDANCE)
- USTRANSCOM/AMC will **NOT** provide face coverings. Cloth face covering shall extend above nose without interfering with eyewear, and below the chin to cover mouth. It shall fit snug but comfortable against the sides of the face and be secured.
- Passengers who disregard this policy are at risk of being removed from their flight.
