Ms. Lindsey H. Wilkinson is the Director of Public Affairs, Headquarters Air Mobility Command, Scott Air Force Base, Ill. In this role, she advises and supports the AMC commander and staff, provides policy and guidance for over 300 Public Affairs professionals, and leads the mobility enterprise's command information, community relations, media operations, security review, and band programs.

Prior to joining AMC public affairs as the deputy director in 2020, Ms. Wilkinson served as the Chief of Operations for U.S. Strategic Command public affairs where she was responsible for the day-to-day operations of the command's media, plans, outreach, command information and digital communication programs. She also served as Chief, Pentagon Operations, at Defense Media Activity (DMA) where she led and supervised a team of public affairs, writer-editor, and audio-visual specialists in planning, developing and disseminating information to worldwide audiences via state-of-the-art multimedia products, social media and the Department of War's flagship website. In this capacity, she served as DMA's liaison to the Assistant to the Secretary of Defense for Public Affairs.



Ms. Wilkinson attended the University of Nebraska-Lincoln on an Air Force Reserve Officer's Training Corps scholarship, and graduated in 2004 with a bachelor's degree in broadcast journalism. Ms. Wilkinson has worked in assignments at the wing, major command, headquarters Air Force, Joint, and DoW levels while on active duty, in the Reserve and as a supervisory government civilian. In 2008 and 2010, she deployed to Southwest Asia as a public affairs officer for operations Iraqi Freedom and Enduring Freedom.
